ANNUAL REGISTRATION FEE

The parent/guardian has to re-register the child each year for the following year if the child is going to attend the School. The registration fee for the following calendar year is non-refundable.

SCHOOL FEES

The monthly school fees are determined each year by the Management of Little Einsteins and is payable in advance. The parent/guardian undertakes to pay the fees in full during the closing period over December/January, even if the school is closed over the festive period. The parent/guardian undertakes not to give notice during November, irrespective of the fact if the child returns to Little Einsteins the following year or goes to Primary School. The last date of notice that can be given for the end of this Agreement is 1 October for the end of October, or 1 December for the end of December. NO exceptions will be made on this rule. The monthly fee is payable in full, irrespective of the reasons a child may be absent in the notice month.

COLLECTION COSTS/LATE PAYMENTS

The monthly fees are payable on the I^{st} day of every month. If payment has not been received by the 7^{th} day of the month an additional fine of R200 will be raised. The parent/guardian will be liable for any collection costs regarding late payments.

BREACH OF CONTRACT

If the parent/guardian is in breach of any of the sections or details stipulated in this Agreement, and fail to mend any such breach within seven (7) days after a written instruction to do so, Little Einsteins will be entitled to, without placing itself at a disadvantage in terms of any sections or other rights it may have, to cancel this Agreement. Little Einsteins upholds the right to claim any damages or loss from the parent/guardian caused by breach of this Agreement.

DOMICILIUM CITANDI ET EXECUTANDI (HOUSE FOR SUMMONING AND UPKEEP)

The parent/guardian chooses the *domicilium citandi et executandi* for the purpose of all notices and/or the signing of any process pieces as indicated on page three (3) of the Agreement.

Any notice or process piece addressed to the parent/guardian will be regarded as received -

on the date of delivery when by hand to the parent/guardian's domicilium citandi et executandi; or seven (7) days after the notice or process piece has been sent by registered mail to the parent/guardian's domicilium citandi et executandi.
